
Exercise Caution and Vigilance

Identifying scammers

Report suspicious behavior right away

A few examples of common scammer behaviors to report immediately include:

Requesting money or financial details, especially for travel costs or medical expenses.

Contacting you from a different country or claiming to be stuck in a foreign place.

Avoiding meeting face-to-face or talking on the phone.

Pressuring you to share your personal info quickly, like your phone number or email.

Urging you to switch to a different communication method than Pornrecruit.com (like texting or calling).

Repeating things often or seeming disconnected in conversations.

Avoiding your questions, giving unrelated replies, or trying to sell you things.
